

# International exchange and travel grants within dance and circus

### **Exchanges abroad**

In order to receive a grant for exchange abroad, you must have an invitation from the organiser/collaborative partner in the country you wish to visit. The invitation must explain what the applicant is invited for, what you are going to do, and when, and which costs the inviting partner inviting party offers (terms and conditions). The invitation must be attached to the application.

Grants for exchange abroad are given to cover certain costs related to guest performances, tours, residencies or other forms of work such as giving a workshop, actively participating in an event or similar activities during the actual period. Eligible costs may include travel, transport, accommodation, meals, participation fee, rental of working space, insurance and visa fees. Salaries and fees are not eligible costs.

Touring means a continuous period of time. When a tour break causes a return trip to Sweden, an application must be sent per continuous tour period.

## **Exchange in Sweden**

Grants for exchange in Sweden are given to cover certain costs related to inviting artists or other artistically active people from abroad to Sweden, for collaboration over a continuous period of time. The focus should be on the benefit the Swedish artist derives from the collaboration. Eligible costs may include travel, transport, accommodation, meals, rental of working space, insurance, visa fees. Salaries and fees are not eligible costs.

### Travel grant

Travel grants give artists the opportunity, without an invitation to travel abroad for a short time in work or educational purposes. The travel can, for example, aim to do research, take a short training course or workshop, visit a festival / conference / event as audience or meet a working partner. Eligible costs may include travel, transport, accommodation, meals, participation fee, rental of working space, insurance, visa fees. Salary and fees are not eligible costs.

## **Application**

Only applicants whose main artistic practices are in Sweden or who are permanent residents of Sweden may be awarded a grant. No grants are awarded for students.

If there are other artists that will participate in the same exhange, you must submit separate applications.

Grants can be awarded retroactively, provided that the application has been submitted before the exchange or the trip has taken place.



Grants are not awarded for exchange or travel in countries or areas that the Swedish Ministry for Foreign Affairs advises not to travel to. Information can be read on the Ministry for Foreign Affairs' website.

If your application is not granted, you may submit a new application, provided that conditions regarding the exchange or the travel have changed after the first decision.

The application should be made through The Swedish Arts Grants Committee's e-portal or in paper form.

### **Assessment and decisions**

The peer assessment group for dance and circus makes decisions about international exchange and travel grants. The decisions are based on an assessment of the quality of the applicant's artistic practice and the content of the planned exchange / travel. Emphasis is also placed on spreading the grants equally, to artists living in different parts of the country and amongst different artistic expressions.

When the exchange takes place abroad, it is considered important how the location and the context of the exchange can be beneficial for the applicant, and whether the terms and conditions offered by the hosting organization or partner are reasonable.

When the exchange takes place in Sweden, an assessment is made of the planned collaboration and how it will benefit artists in Sweden.

Decisions are notified by e-mail about 6 weeks after the last application date. Decisions cannot be appealed.

## Payment and taxes

Grants for international exchange and travel grants are paid within 6 weeks after decision to the personal bank account, with yourself as the account holder, that is stated in the application. The grant is tax-free.

### Report

The exchange / travel should be carried out according to the application. If the exchange changes in an essential way to what is stated in the application, or if for some reason it is canceled, The Swedish Arts Grants Committee is to be contacted immediately. Changes must be approved before the exchange, otherwise it could mean that the premium or part of the grant must be repaid.

Within one month after the exchange / travel has been completed, a written report must be submitted to The Swedish Arts Grants Committee on a form which can be downloaded at the following link: https://www.konstnarsnamnden.se/stipendier-och-bidrag/redovisning-av-bidrag/

If the grant is not reported, The Swedish Arts Grants Committee may demand reimbursement, and this may affect your chances of receiving support from The Swedish Arts Grants Committee in the future.
