

# Project grants for dance and circus

You can apply for a project grant for a limited experimental or developmental work. The project shall have a clearly defined goal, be time-limited and have a budget.

For example, you can apply for a grant for creating new artistic works as well as testing new ways of working or developing new techniques.

You can apply for project where you collaborate with other artists or other colleagues. The grant shall be used for costs that are directly related to the project, such as wages for yourself or other participants, materials, rent of premises or travel.

The budget shall include VAT. If you apply for a project that has already started, you can only apply for cost you have after the date of decision. You cannot apply for grants to tour cost of pre-produced works.

### **Application**

Applications should preferably be made by logging on with your e-legitimation (Swedish electronic identification) to the Swedish Arts Grants Committee's website: www.konstnarsnamnden.se

If you can't apply through our e-service you can fill in a pdf-form and email it together with your work samples to ansokan@konstnarsnamnden.se or post it to the Swedish Arts Grants Committee, Maria skolgata 83, SE-118 53 Stockholm, SWEDEN.

**NB!** To be considered, your application must reach The Swedish Arts Grants Committee no later than the application deadline.

#### Applicant and participant

Even if several artists collaborate on equal terms, only one person can be the applicant. All others are "other participants". Other participants who are stated in the application must be informed in advance of this fact.

### Work samples

Work samples are obligatory and must be attached to the application. The work samples should give a clear picture of your artistry and should not be older than 3 years. It is important that you can be identified if you are in the material, especially if the work sample refers to work in a group.

1-2 videos

Size: max 250 MB in all Format: mp4 or mov

Links to moving material on, for example, Vimeo, YouTube or website can be listed in the application or attached as an attachment but do not replace the mandatory work sample as described above as links are not archive-resistant. Make sure the links work and enter passwords when needed.



### Payment and taxes

Payment is made through requisition and it is paid to the applicant's personal account. Project grants are a taxable income for the recipient and must be requisitioned in the same calendar year as they are granted.

When transferring project grants to legal entities, a written agreement should be signed between the beneficiary and the legal entity on the implementation of the project. The beneficiary is responsible to the Swedish Arts Council for the presentation of the grant.

For artists who carry out VAT-liable activities, VAT may be raised even though there is no VAT on the project grant. This applies provided that the purchases are directly and immediately related to the VAT-liable business for which you must report VAT.

### Report

If you are awarded a project grant, you must submit a written report within a month after the completion of the project. Information about what the report should include is available on The Swedish Arts Grants Committee's website.
